You may access from your desktop

- 1) If you choose to view from your desktop you will need to register as soon as possible to avoid any technical problems and so you will be able to view the video at the starting time.
- 2) Access the NCA Net Website: <http://www.mrcac.org/ncanet-educationcalls>
- 3) Find the call by date or topic name and click on the "register" link. This will walk you through a series of screens and ultimately will take you to a link called vstream/video guidance where you will also need to register and create a username and password.
- 4) Once logged into video guidance, you should see the name of the video call on the left side of the screen. You may need to click the "register me" link next to that video.
- 5) If your machine does not have Microsoft Silverlight installed, you will be prompted to install it before you can view the video.
- 6) Once this process is complete, you should be able to access the video conference. You will be able to ask questions via live chat by clicking on the button with the conversation bubble symbol.
- 7) After the conference, you will be prompted to complete the evaluation and will then receive your CEU's, CLE's, etc.
